ORDINANCE NO. 217

AN ORDINANCE OF THE CITY OF KOOTENAI, IDAHO, AMENDING THE ANNUAL APPROPRIATION ORDINANCE NO. 212 FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2016, APPROPRIATING ADDITIONAL MONIES THAT ARE TO BE RECEIVED BY THE CITY OF KOOTENAI, IDAHO IN THE SUM OF \$59,000; PROVIDING FOR REPEAL OF CONFLICTING PROVISIONS AND FOR AN EFFECTIVE DATE UPON PUBLICATION.

<u>Section 1</u>. That Ordinance No. 212, the appropriations ordinance of the city of Kootenai, Idaho, for the fiscal year commencing October 1, 2016, be and the same is hereby amended as follows:

That the revenue for fiscal year 2017 increase \$59,000 in the general fund from \$171,715 to \$230,715 and that the same amount, \$59,000 is appropriated from the general fund to defray the necessary expenses and liabilities of the city of Kootenai, Bonner County, Idaho.

<u>Section 2</u>. Tax Levy unaffected. That the tax levy established for the city of Kootenai for the Fiscal year beginning October 1, 2016, shall be unaffected by this ordinance.

<u>Section 3</u>. All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

<u>Section 4</u>. This ordinance shall take effect and be in full force upon its passage, approval and publication in one issue of the Bonner County Daily Bee, a newspaper of general circulation in the city of Kootenai, and the official newspaper of said City.

PASSED under suspension of the rules upon which a roll call vote was taken and duly enacted an ordinance of the city of Kootenai, Bonner County, Idaho at a convened meeting of the Kootenai City Council held on the 23rd day of August, 2017.
