**DATE:** August 2, 2022 **TIME:** 6:30 p.m.

Mayor Lewis brought the meeting to order at <u>6:30</u> p.m. City Clerk opened the telephonic/video line for phone and/or video attendance.

## 2. Reports:

- **2.A.** Mayor: Mayor Lewis informed Council that she had help tend the Urban Area Transportation station during the Sandpoint Crazy Days event. She advised that the purpose of the station was to take public comment and input.
- **2.B.** City Engineer: Written Report Summary Attached Specific topics were discussed:
- 2.B1 TAP Grant Pathway Ryan stated that the City had been granted the funds for the TAP Gran Pathway that had been approved and submitted. He advised that the Local Highway Technical Assistance Council had sent a Design State Local Agreement to the City for the proposed pathway from Seven Sisters to Main Street along SH200 for Mayor's signature. Councilwoman Mjelde moved to authorized Mayor Lewis to sign the State/Local Agreement for Project No. A022 (946) SH-200 to Railroad Ave Path, 2<sup>nd</sup> by Councilman Schock; roll call vote:

2.B2 Children Pedestrian Safety Program Grant – Ryan advised that the City had been awarded the grant request of \$250,000 for the 2<sup>nd</sup> Avenue from the Kootenai Elementary School toward the Seven Sisters Development, He expressed his excitement that the city of Kootenai had ranked number 1 which meant that it scored the highest in the state for applications received. He stated that the City had received the LHTAC/Local agreement which need to be signed and submitted. He advised that once the signed agreement was submitted the City would receive the funds and it was a no match grant. Councilman Sundquist asked if the residents along 2<sup>nd</sup> Avenue would be informed that they will need to remove and/or relocate. Ryan stated that the residents will be well informed and will have plenty of time to remove and/or relocate items from the City's rights-of-ways. Councilwoman Mjelde moved to authorize Mayor Lewis to sign and have the Agreement submitted, 2<sup>nd</sup> by Councilman Schock; roll call vote:

- **2.E. Selkirks-Pend d'Oreille Transit (SPOT)** Mayor Lewis stated SPOT had found a new director, but it did not work out as he could not find living quarters in the area, and they are now looking for a new director.

Executive Session Mayor asked for a motion to move into executive session at 7:28 p.m. Councilman Rafferty moved to enter into executive session in accordance with Code §74-206(f) to communicate with legal counsel for public agency to discuss the legal ramifications of and legal options for pending litigation, or controversies not yet being litigated by imminently likely to be litigated, 2<sup>nd</sup> by Councilman Sundquist; roll call vote:

Council reconvened into the meeting at 7:42 p.m.

### 4. <u>Discussion/Action Items</u>

**4.1** <u>Lignetics Update</u> – Ronda advise that the City had received a response to the letter of concern sent to them on July 14, 2022 advising that Legnetics is/has addressed the City's concerns. She stated that the City had not received a final inspection report from Northside Fire Department to date. Council advised Ronda to request a final report and an update on the fire code related to the height of the sawdust pile. Councilman Sundquist expressed his concern that the screening was still not adequate.

- **4.2** Bonner County Historical Society Free Title Council agreed that there was not enough information present to pursue an objection of the free title action.
- 4.3 <u>Code Enforcement Title 4 and 8 Enforcement</u> Councilman Sundquist moved to pursue criminal action on all City Code 8-10A-B violations, 2<sup>nd</sup> by Councilwoman Mjelde; roll call vote:

4.4 – <u>Surplus Inventory</u> – Ronda stated there were several items that needed to be either sold or donated. Councilman Schock confirmed that to sell surplus items the City must publish an add in the paper. Council suggested that all unusable or unneeded items be donated or thrown away if unusable. Councilman Sundquist moved to allow the City Clerk to donate or trash surplus inventory at her discretion, 2<sup>nd</sup> by Councilman Rafferty; roll call vote:

4.5 <u>3<sup>rd</sup> Quarter Financial Report</u> – Ronda advised that the report was in good order. Re: Council Meeting Report for July Engineering Activities

I was on vacation for a portion of July. Engineering activities for the month of July were limited but included coordination with utility providers, City drainage review and coordination with IHD, and SH 200 pathway discussion with LHTAC.

#### **Ditch Maintenance Update**

The Independent Highway District crew cleaned the ditches where standing water was observed. This area was along a portion of W 1st Avenue, Sprague Street and Railroad Avenue.

#### **Children Pedestrian Safety Grant**

The City applied for \$250,000 to widen 2<sup>nd</sup> Avenue from the Kootenai Elementary School toward the Seven Sisters Development to add a shoulder space for pedestrians. The City's application ranked number 1, which means it scored the highest in the state for applications received. A check for \$250,000 will be sent to the city, after the LHTAC/Local agreement is signed and returned.

#### **TAP Grant Pathway**

The Local Highway Technical Assistance Council sent the City a Design State Local Agreement for the proposed pathway from Seven Sisters to Main Street along SH200. The federal project is referenced as Key No. 22946, SH200 to Railroad Ave Path, City of Kootenai.

The agreement is required for federal-aid projects and outlines the roles for securing the design services. This document needs to be signed so that the funds can be obligated. For this project, ITD staff are performing the design services along with the design of the SH-200 safety project. It may be possible to move some of the money proposed for project development to construction if consultant engineering fees are not utilized for this project.

#### **Utility Permits**

**ENU 006-021 (TING)** – TING's contractor is continuing with installation of underground infrastructure for fiber optics with a good portion of the underground boring work in-place. Repair of the exploratory holes, installation of the fiber optics and utility boxes will continue into August.

**ENU 007-021 A, B, C (Ziply)** – The Ziply work has been completed. The contractor replaced a couple sidewalk panels on First Avenue adjacent to the school property and repaired some damaged asphalt on Second Avenue between Helena Street and Seven Sisters Drive.

**ENU 002-022** – A utility permit for the installation of water and sewer hookups at 401 & 403 Helena Street was issued at the end of June. The Utility work has been performed in advance of the Independent Highway District's future project which includes placing rock on this section of the roadway.

Planning update for August 2, 2022, City Council meeting

**Building permit activity:** ADVISORY. The City of Kootenai received one new building permit application in July for the completion of the upper story of the Kootenai Community Church on North Main Street. The total number of applications for the year is nine.

Land Use Application Activity: ADVISORY: L<sub>3</sub>M, LLC, owners of the former Coldwater Creek campus, have submitted an application for a minor subdivision of the 12-acre parcel into four lots. The application is an administrative plat and will be reviewed by affected agencies. In addition, a public notice to landowner within 300 feet will be provided. The city planner will provide a written report to City Council containing proposed findings, conditions, and recommendations. The Council will consider the application at a public meeting (not a hearing), after the report is issued. The "Kootenai Campus" preliminary plat shows a 7.17-acre lot proposed for the existing main building, a 1.18-acre lot for the Litehouse building, a 2.23-acre lot for the office building, and a 1.39-acre vacant lot facing State Highway 200. Although a public hearing is not required for this type of proposal, since it does need to come before City Council for final action, this should be considered a quasi-judicial file type, meaning there should be no ex parte contact or site visits.

The Kootenai Commerce Center site plan permit remains under review. The site is located on the south side of State Highway 200, adjoining Lignetics. Additional information has been requested from the applicant regarding infrastructure, lighting, access, landscaping, stormwater, and other details.

Comprehensive Plan Amendment, Bonner County ACI notice: ADVISORY: Bonner County Planning Commission has initiated an amendment to its comprehensive plan goals, objectives, and policies. The notice and invitation to comment has been provided to all taxing districts and cities. The complete text of the proposed amendment, last updated in 2005, is available for review under the "current projects" tab of the planning web site. The proposed changes include: restructuring sentences and paragraphs; updating census figures and adding local trends; addressing school needs as they relate to public land use policy; tune-ups to the economic, hazardous area, natural resources, and other sections. Summary notes from the Commission and "points for further discussion" are included in the proposed update. The comment period ends August 24, 2022. A hearing has been scheduled for August 30<sup>th</sup>.

**Kootenai City Code Land Use Update:** City Council conducted a workshop July 27<sup>th</sup> to review zoning codes and possible updates regarding wireless communication facilities, RV occupancy and storage, accessory living units, and the Downtown zoning district allowed uses. Staff will use the comments and suggestions from the Council to develop a draft code update document for further discussion at a later date.

#### **Patrol Highlights**

- Harassment RP called and reported she was being harassing. Officers mediated complaint and encouraged the RP to block the suspects phone number and the suspect was trespassed.
- Sex offense RP called to report he heard a rumor his cousin has had sex with an adult male. This information was not first hand and he does not know the males name. Follow up to be completed.

- Fireworks complaints –
- Fire structure Officer responded to 32131 Highway 200 for the report of a structure fire. Officers arrived in the area where unable to locate any fire anywhere in the area.
- Disorderly Rp reported her boyfriend was throwing all of her things out of the front door. Upon officer's arrival to find he had already left. Officers assisted in carrying some items back inside.
- Theft Several tools were stolen out of the back of a vehicle located at 323 McGhee Road; Panhandle Pump & Irrigation in Kootenai. Under investigation
- Fight Officers responded to Arnies gas station for a fight that started because of road rage. Two males were located and identified, however officers were unable to determine who started the fight.
- Battery RP called claiming multiple people were at his residence and were refusing to leave and had threatened him with guns and hammers. Upon arrival, it was discovered RP had actually instigated and battered one of the individuals who lives at this residence. Ultimately he did not wish to press charges and the RP was again instructed on the proper way of going about a civil eviction process.
